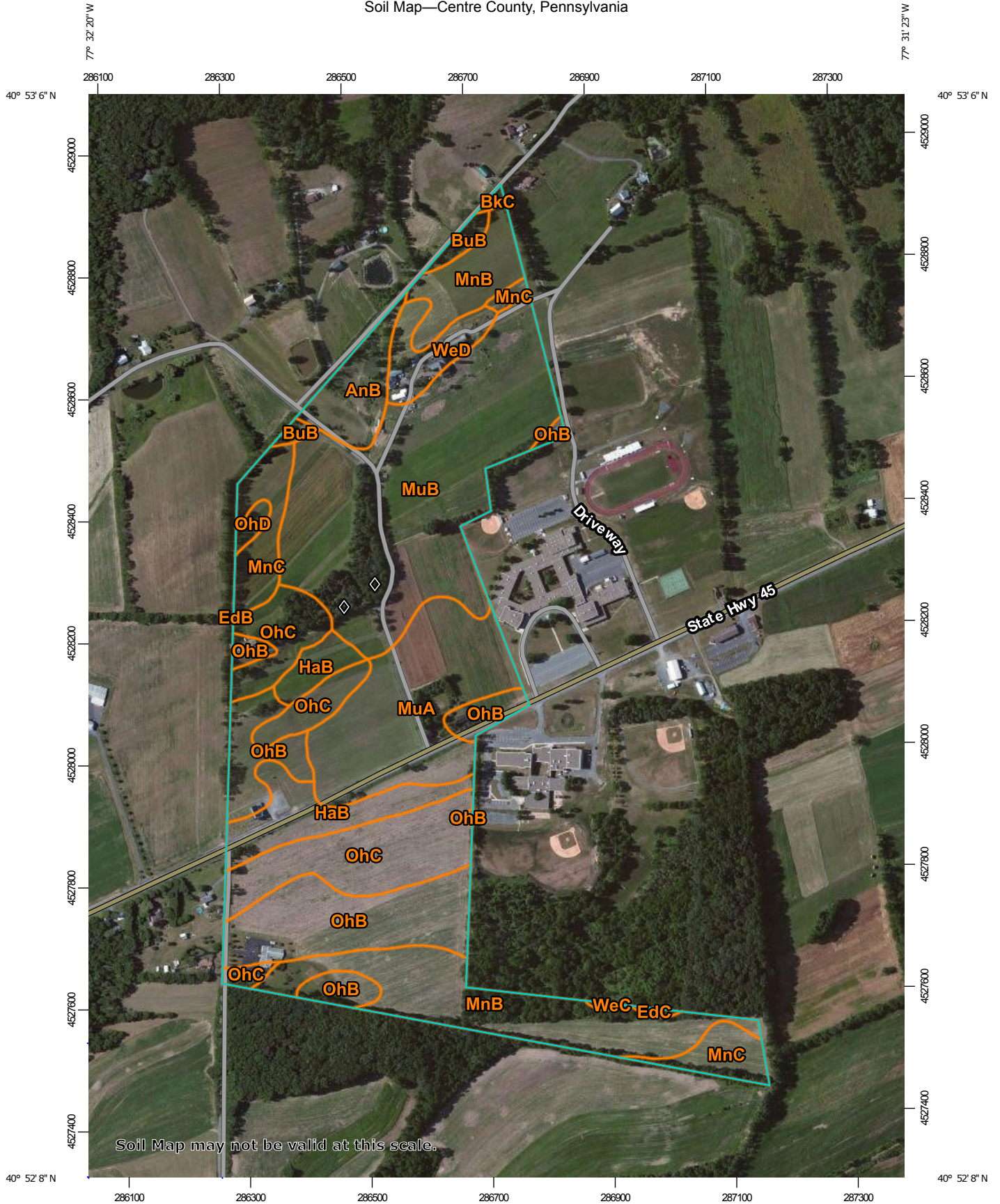
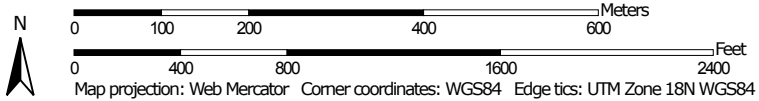


Soil Map—Centre County, Pennsylvania
